Upon completion by any member of <u>their</u> term as Past President, that member shall not be eligible to serve on the Board in any elected position for one year following the end of <u>their</u> term as Past President. <u>In the event the</u> <u>Past President resigns or is removed prior to the end of</u> <u>their term, that member is not eligible to run for any</u> <u>elected position for one year following the original term</u> <u>period.</u>
